A MESSAGE FROM THE PRESIDENT, CELESTE SUTTER, CHMM

Dear Fellow Chapter Members,

term of one year and agrees to serve as the Immediate Past President for the following year. The President shall preside over Chapter meetings and interface with other Chapters, AHMP, and other environmental organizations; submit the annual report of activities of the office of the President to the members; and plan the Annual Meeting. The current President is Celeste Sutter and the current Vice President Larry Schumer agrees to be on the slate to run for this office.

Vice President: The candidates for Vice President must be a CHMM and in good standing with the Chapter and be willing to run for President and serve as Immediate Past President in the subsequent years. The Vice President shall preside over Chapter meetings in the absence of the President and serve as Programming Chair, coordinating all the technical sessions for each of the meetings. The current Vice President is Larry Schumer. The Chapter generally sponsors the Vice President (all expenses paid) to attend the AHMP Leadership Conference and has the opportunity to attend the National Conference as the Chapter Delegate with expenses covered by the Chapter and AHMP. The 2012 AHMP National Conference will be held in Anchorage, Alaska, September 9-12, 2012.

Secretary: Candidates for this position must be in good standing with the Chapter. The Secretary is responsible for documenting Chapter and Board meetings, including any e-meetings; maintaining and updating Chapter records, documenting Chapter sponsored training and all official correspondence of the Chapter. The current Secretary is Brad Coyle.

Treasurer: Candidates for this position must be in good standing with the Chapter. The Treasurer is responsible for documenting membership in conjunction with the Membership committee, maintaining the Chapter financial records, and interfacing with government regulators to maintain Chapter non-profit status. The Treasurer reports the status of all funds at each membership meeting and assists the Board in preparing regular Chapter financial reports. The current Treasurer is Vickie Sammons.

Directors- at-Large: Candidates for this position must be in good standing with the Chapter. Directors are asked to contribute a feature article for inclusion in the quarterly newsletter and to serve on other committees or assist with new initiatives as needed to carry out implementation of Chapter goals and objectives. The current Directors are Bruce Gaylord, Tom Herman, Mark Hussung, Ralph McCord and Kenny Reutlinger.

Board meetings are held at 4:00 PM on the first Wednesday of alternate months, prior to the Chapter meetings and technical sessions. If you need further details about what is involved with individual positions, please contact the current board member.

REPORT FROM THE 2011 AHMP CONFERENCE IN AUSTIN, TEXAS

The 2011 AHMP Conference was an amazing experience. Conference is a great way to get your continuing maintenance points for your CHMM credential. The KCHMM Chapter was well represented.

This year the conference content was excellent. The offerings included topics ranging from stack testing to sustainability tips to ISO 14001. To me, the most interesting thing about these three diverse topics is that they were all presented by members and former members of KCHMM. Jonathan Eckles, who is now President of the Gateway Chapter in St. Louis, had a great presentation on the pitfalls of stack testing. He had a great handout called "Stack Testing for Dummies." It's actually a promotional booklet from a vendor, but it's a good tutorial on the basics. Give him a shout to learn how to get a copy.

Brent Fryrear explained the Louisville Green Cities initiative and generously offered to help any of the attendees with their questions and projects. Jennifer Triplett used her expertise as an ISO 14001 auditor to help folks improve the basis of their ISO 14001 Environmental Management Systems.

Can you see or hear any of these presentations online? Possibly. The difference is getting the opportunity to interact with the presenters and network with folks from all over the country. Terry Tamminen was the keynote speaker. One of the more interesting points he made concerned climate change. Regardless of your personal opinion on the global warming debate, he pointed out that there is indisputable data that demonstrates the average low temperatures are going up. His point is that surfaces are not cooling down as much as happened in the past and he believes this will have important consequences for all of us.

The luncheon speaker, and I use that term loosely, was Steve Laughlin. Steve has an inner performer that most of us never see. As part of the luncheon presentation he performed three original songs, each showcasing the foibles of our favorite regulatory agencies. OSHA, EPA and DOT all were exposed without mercy and the attendees enjoyed it immensely.

The exhibit hall offered all of us an opportunity to look at new products and to get ideas for possible improvements to our personal work efforts.

Next year the conference is in Alaska. The dates are early in September. Hope to see you there!

"GHS — Globally Harmonized System for Classification and Labeling of Chemicals"



CHMMS ON LINKEDIN

LinkedIn is a professional network with over 80 million members. It has members from over 200 countries worldwide. It's a social networking site – like Facebook or MySpace but for professionals. It is a place to exchange ideas, meet industry experts and find job opportunities. The exchanges are professional in nature. No posting of family pictures or chatting with old classmates. Instead, you follow industry specific exchanges and dialogue with other professionals with similar credentials as yours.

The primary networking opportunities with LinkedIn are "Groups" and "Connections." Groups allow you discover popular discussions in your profession. You join "Groups" within your profession. For example, the Institute of Hazardous Materials Managers has a Group on LinkedIn with more than 1800 members. The IHMM Group on LinkedIn is very active and informative. You can post questions and start or participate in discussions. It is like blogging but for professionals. BCSP and AIHA also have Groups on LinkedIn. You find Groups on LinkedIn by using a keyword search for Groups. For example, type "waste management" or "environmental engineer" to find dozens of Groups with members with similar interests and professional objectives.

I find LinkedIn to be extremely useful in my professional endeavors. As a regulatory compliance person, often there are regulations about which I could use a little expert advice. When Taiwan enacted new chemical control legislation, I joined a Taiwan expert group. I posted questions in the Groups discussion area. LinkedIn members from across the globe shared their expertise and pointed me to line and verse of regulatory text to help me understand the Taiwanese requirements. I use LinkedIn often in this way. I also offer my help to other professionals when their questions fit my expertise.

"Connections" in LinkedIn allow you to connect with industry experts and colleagues. People who are in your "Network" on LinkedIn are called your "Connections." To "connect" with someone on LinkedIn, you should already have a trusted business relationship with them. You know them from a previous job, you have worked with them as a consultant, or you belong to a common professional organization or Group on LinkedIn. Just like with other professional networking, "Connections" in LinkedIn can help you find a job, increase consulting opportunities and improve your visibility.

Joining LinkedIn is easy and free. (Of course, you can upgrade your membership for a fee.) There is no limit to the number of Groups you can join. You can edit your profile to receive daily or weekly email digests of Group activity or receive none at all. Go to www.linkedin.com
