A MESSAGE FROM THE PRESIDENT, PAUL TIREY, CHMM

HIGHLIGHTS FROM JANUARY'S MEETING

At January's meeting, Jonathan Eckles, CHMM, presented "Adventures In Stack **Testing: Lessons** Learned". His presentation focused on his experiences performing stack tests for an industrial incinerator permitted within the Commonwealth of Kentucky. Jonathan stressed the selection of a wellqualified contractor, as well as the necessities such as electrical requirements and equipment preparation.





Here, Jonathan shows the testing setup at the top of the vent stack. A focus of his presentation was the need for the proper fuel resources and waste/ process materials for sustained testing over an extended period of time. Jonathan also stressed the need to take care of the contractors, whose schedule often did not allow for meal breaks. Said Jonathan: "Order lots of pizza!"

As your new Education Chair for the KCHMM chapter, I would like to thank you for giving me the opportunity to serve you in 2009! Let me share with you some upcoming opportunities that you may want to pursue.

First, as everyone knows, ACHMM has been re-branded into the AHMP. To access the AHMP website, you can still enter <u>www.achmm.org</u>, into your web browser. If you are looking for any training to help accumulate CMP points, you have several options available through the website (under "News/ Events/Learning") as follows:

> Webinars In-class training for CHMM exams On-line training

For the on-line training it is important to note that you can complete it from the convenience of your PC. You will have to pay for your own course. I have not actually taken one, they usually take as little as 30 minutes to 1 hour. Also, my understanding is that you can complete each course incrementally according to your own schedule.

Second, the 2009 AHMP National Conference will be 8/30/09 to 9/2/09 in San Diego, CA. The Conference is a great opportunity to network and share best practices with other EH&S professionals from CHMM chapters nation-wide. Registration for the Conference begins on 3/15/09. Next, please continue to spread the word about the Certified Hazardous Materials Practitioner (CHMP). This new certification is designed for those EH&S professionals who do not necessarily have a college undergraduate or advanced degree, but have gained sufficient knowledge and competency through their career experience.

Finally, KCHMM has sponsored a "CHMM Exam Review" training course in the past. For those of you planning to sit for the CHMM or CHMP exam, or if you are just a CHMM wanting a good refresher, this course is for you! However, we need at least 10 people to justify the time and expense to implemented.

ACHMM NAME CHANGE: ALLIANCE OF HAZARDOUS MATERIALS PROFESSIONALS

With this new brand identity we will lower this veil of secrecy to introduce all industry professionals to our association and open their eyes to our many outstanding membership benefits.

"Our new brand identity will help us accomplish this goal," continues Calhoun. "It will help inform all EHS&S professionals that



they can join us and take advantage of the many top-notch professional development and educational programs, industry networking opportunities and other benefits we offer our members."

The new brand identity comprises the new organizational name; a modern logo; and a tagline: "Global leadership for a sustainable future™". This new brand identity package was developed by a Branding Task Group, chaired by Past President John H. Mitchell, CHMM, comprised of prominent past and present organization leaders and charged by the organization's Board of Directors to create "a new organizational name that will appeal to all professionals in the environmental, health, safety and security industry."

CHANGES TO CHMM RECERTIFICATION STANDARDS

IHMM recently revised the Recertification Standards for maintaining the CHMM qualification. Below are some examples of changes to the Certification Maintenance Points structure, and the number of points now offered for each activity.
